**Financial Report Summary**

The St. Louis Ski Club report of Income and Expenses is for the period May 1, 2013 to April 30, 2014. Income for this fiscal year was \$6,597.22 and Expenses were \$11,637.46. There was a Trip Profit of \$8,574.67. The total net profit for the year was \$3,534.43.

Our main sources of income are membership and trip administration fees. The Holiday Party in 2013 raised \$215.00. This was offset by expenses of \$179.70 for a net profit of \$35.30. Changes in the Holiday party format for 2013 eliminated large past losses.

The expense of printing and mailing the Sitzmarker has also been reduced with the change to sending it electronically to members with e-mail at the start of this past fiscal year. Arrangements have been made for members who do not have e-mail to receive printed copies. The same holds true with trip forms and letters and future directories.

The Board of Directors continues to try to be fiscally responsible to the membership. Last year the size of the board was reduced, and we also cut expenses by changing the location for our general meetings. Our goal is to try to increase income while reducing expenses in a responsible manner.

## Crested Butte: America's Last Best Ski Town!

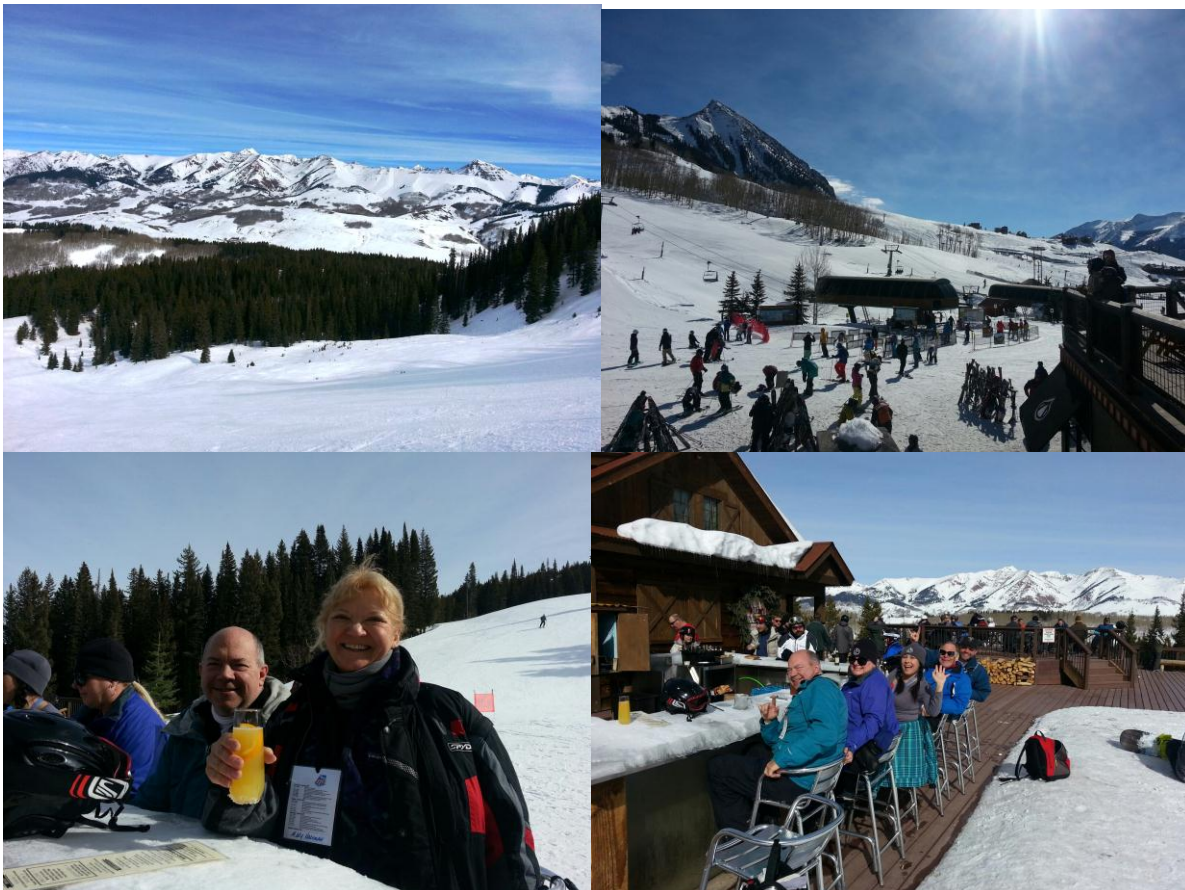

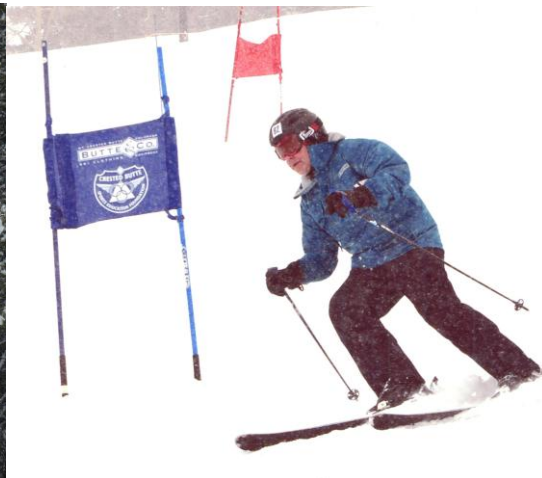

## The Flatland Ski Association – Since 1965

*Shi Faster ... until the thrill of speed overcomes the fear of death!*

The St. Louis Ski Club has been a part of the Flatland Ski Association (FSA) since 1966 ... but how much do you really know about the FSA and who's part of it?

The FSA races began March 21, 1965 in Crested Butte, Colorado. The Kansas City Ski Club originated and hosted the first event, and it took two years of challenges before others accepted. The first year it was clubs from Kansas City, Omaha, Amarillo, and Wichita. St. Louis joined the second year and participated regularly through 1982, then was "in and out" for a number of years following that. But we've been regularly participating in FSA events for the past 10 years!

The first year there were 40 racers, and this year there were approximately 350 people who came to the event, most of whom participated in at least one of the races. There have been as many as 12 clubs in the FSA over the years, but in recent years it's been 9 core clubs from the Midwest: St. Louis, Columbia (MO), Kansas City, Topeka, Wichita, Lincoln (NE), Omaha, Oklahoma City, and Tulsa. Each club has a volunteer who sits on the FSA board, and all of the FSA officers are also volunteers. They put in countless hours of planning for the events each year just because they enjoy the fellowship and the racing! (*Bragging rights in some cases, too, but all in fun!*) In recent years Candy Girth has served as the FSA Activities Director and Bill Hayes as the FSA Race Director, coordinating those events for *all* the clubs. Paul Snyder has been the St. Louis FSA representative for the past few years, and was elected FSA Vice President in January, so he'll begin those duties this spring. Our club *will* be looking for a Club Race Director for next year's event! Interested? Talk to Paul or Candy about what's involved. There's a one-day meeting in the summer, some "online" work just before the trip, and a few things to attend while at the FSA event!

The races *are* the main reason for this annual event, and this year was the 51<sup>st</sup> year of racing! There are challenge races for men and women (*by age brackets*), an "open" race that anyone can pay to participate in, and a novice race for those who haven't competed in the challenge races in the past or haven't won Nastar or other medals in the past. There's also normally a "team" event, which for the past several years has been a snowshoe relay race. It is one of the most entertaining things to watch! And every year the individual club Race Directors have a "fun race" and sell tickets to raise money for the charity the FSA adopts each year. In 2015 it was the Crested Butte Adaptive Sports Center. This year SLSC members Bill and Judy Hayes both won medals in their challenge races, and Candy Girth represented the club as our Race Director in the "fun" race!

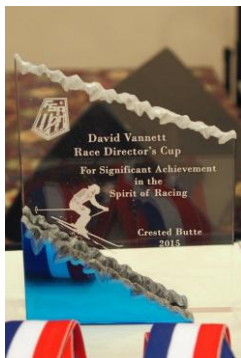
The FSA also give out other awards, besides just the race winners. The **Dave Vannett Race Director's Cup** is presented by the club race directors to whomever they feel has made a significant achievement in racing. Sometimes an individual, and sometimes a club. This year's award went to the Columbia Ski Club, and was presented to the club with the most points earned per skier participating.

Another award presented is the **Judy Cup**, named after a true Flatlander, Judy Nania of the St. Louis Ski Club. After her death in 1989, her husband Vince honored her memory with this award. Each year this beautiful cup is presented by the FSA Board to an individual who has made exemplary contributions to the FSA, demonstrating service and sportsmanship in the true FSA spirit!

## Park City: A Resort 50 Years in the Making!

Co-captains Larry Essmann and Pat Pender led this year's trip to Park City, Utah from February 7<sup>th</sup> – 14<sup>th</sup>.

Nineteen members of the St. Louis Ski Club departed for fun and adventure in Park City, Utah on Saturday, February 7<sup>th</sup>. Under the guidance of trip leaders Larry Essmann and Pat Pender, this group included Denise Buehrer, Pat Cannon, Alan Fiddleman, Rich Florman, Ed Goedde, Randy Helms, Betty Hillig, John Hutchens, Don Logie, Dan McGurk, Julie Rovics, Bob and Chris Schnieders, Carole Stevenson, Susanne Watkins, and John and Erni Wood.

We departed from the St. Louis Airport at 2 pm on Saturday, which was considered an auspicious start for those who have not enjoyed early morning flight times on past trips. The non-stop flight to Salt Lake City and bus transport to our condos in Park City both went without a hitch and we arrived with plenty of time to pick up ski rentals, enjoy some dinner, and even make a run to the grocery and liquor stores to stock the condos.

The snowfall was not as much as we would have liked, and we unfortunately found that snowmaking had been shut down for the year due to a water shortage. The skiing was still decent, though, especially on some of the upper runs. Over the course of six ski days, different groups alternated between Park City and Deer Valley with nearly everyone finding runs that met their comfort level. Dan and Larry did make a wrong turn at one point and ran into some "challenging" (to say the least) moguls; they made it down them, although not entirely gracefully and in Larry's case not entirely upright. Denise and John Hutchens took on a competitive spirit for their last run of the trip on Friday. They ran the NASTAR course at Park City with Denise collecting a bronze medal.

The condo shared by Pat, Larry, and Alan was a popular gathering place as it hosted the welcome party on Sunday night and the club party on Thursday. There was plenty of snacks at the welcome, plenty of pizza and salad at the club party, and plenty of beer and wine at both. People found plenty of other fine dining options in and around town on the other evenings, with cuisine ranging from Mexican to Italian to good old American standards.

There were some hearty souls who chose to take advantage of all six skiing days but many chose Wednesday as a day of rest. It was a fairly mild day to wander through town and take in some of the shops and restaurants. Larry, Pat Pender, and Pat Cannon opted for a little more excitement by riding the Alpine Coaster at Park City Mountain, an adventure described on its website as "whizzing down the mountain on nearly 4,000 feet of curves, bends and loops" and "a ride you won't soon forget." To make sure they didn't forget it, these three decided to go on it twice.

For dinner on Wednesday evening, the club diverged in two opposite directions. About a dozen went to a dinner Larry had arranged at Cisero's Restaurant for some fine Italian cuisine. About seven others ventured out to Deer Valley for some fireside dining at the Empire Canyon Lodge there. This consisted of cuisine from the European Alps cooked at four different roaring fireplaces throughout the lodge and diners moving between these stations. Food included leg of lamb, Raclette cheese, stuffed quail, trout, and dessert fondue. Carole Stevenson summed this up quite simply as being "quite a unique dining experience".

After a solid week of skiing, we headed for home on Saturday. Our bus to the airport did not leave until 2:30 pm which gave people a little bit of down time after packing up and checking out of the condos at 10 am. Some people traveled to Deer Valley for a late breakfast/early lunch while others opted for another stroll through Park City. The non-stop flight from Salt Lake City was on-time and uneventful and had us back to St. Louis at about 9 pm.

While the snow conditions were not ideal, this trip still proved to be an enjoyable one with good skiing, good fellowship, and good memories, and a lot of credit going to Larry and Pat for their solid planning and leadership. Park City has been a popular destination for the club in past years and this trip should help solidify its reputation as a fun and challenging resort.

Some of the sites include the Matthias Church, site of many coronations, the Fisherman's Bastion, Old Buda and Gellert Hill, plus the Parliament. Again, during your free time you'll be able to visit shops, museums, and all sorts of fantastic places to eat! 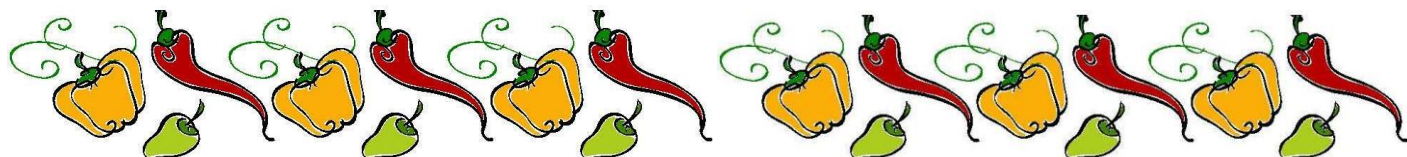
