## Financial Report Summary

The St. Louis Ski Club report of Income and Expenses is for the period May 1, 2014 to April 30, 2015. Income for this fiscal year was \$6,603.77 and Expenses were \$9,897.01. There was a Trip Profit of \$1,530.36. The total net loss for the year was \$1,762.88.

Income was up \$6.55 from the prior year, and expenses were down \$2,000.00 but, even so, with some trips that didn't fill and others that had unexpected expenses, our trip profits were down by \$5,281.43 this year.

The expense of printing and mailing the Sitzmarker significantly reduced our expenses from the past fiscal year. Eliminating the position of Past President also was a major savings in trip credits.

The Board of Directors continues to try to be fiscally responsible to the membership. Moving our meetings to Ruby Tuesday's, and seeking alternate locations for the chili cook off as well as the change in the structure of the holiday party will continue to reduce our expenses as we move forward.

Limiting the number of ski trip and offering trips that we hope will fill will also help balance our year end bottom line as we move forward.

## Member Spotlight: Denise Buehrer

It may sometimes take some incredible endurance to complete a challenging ski run but it's not likely that many of us would compare that with the stamina it takes to run a marathon. In fact most of us will never be in a position to make such a comparison. But one member of our ski club, Denise Buehrer, can claim this distinction.

Denise works by day as a project architect at Christner Inc. but has a variety of other interests to occupy her spare time. She has been a member of the ski club since 1997 and also engages in running and bicycling to keep physically active. She has also dabbled in photography. Since 2009 she has participated as a member of Team Christner in Bike MS, annual fundraiser for the National MS Society.

In November of 2015, Denise traveled to Tulsa, Oklahoma to compete in the Williams Route 66 Marathon. She understandably wanted to run her first marathon in relatively cool weather and this gave her the chance to run part of the marathon with her sister, who had run multiple marathons, including the Boston Marathon. Denise managed to keep up her pace for about 18 miles but then started to slow a little bit and started walking at mile 24. She did finish, though, and even received a special coin for taking a detour that added 0.3 miles to the course and received a special coin for the "World's Shortest Ultra" (an Ultra being any race over the marathon distance of 26.2 miles). Most of us can only imagine the thrill Denise must have felt when she crossed the finish line and heard a Runner's World magazine columnist announce "first time marathoner coming through".

As we are finding with many ski club members, Denise has many interests beyond her day job and beyond the ski slopes. We will be watching with interest to see if her first marathon leads to others down the road.

# Aspen, Colorado - The Power of Four

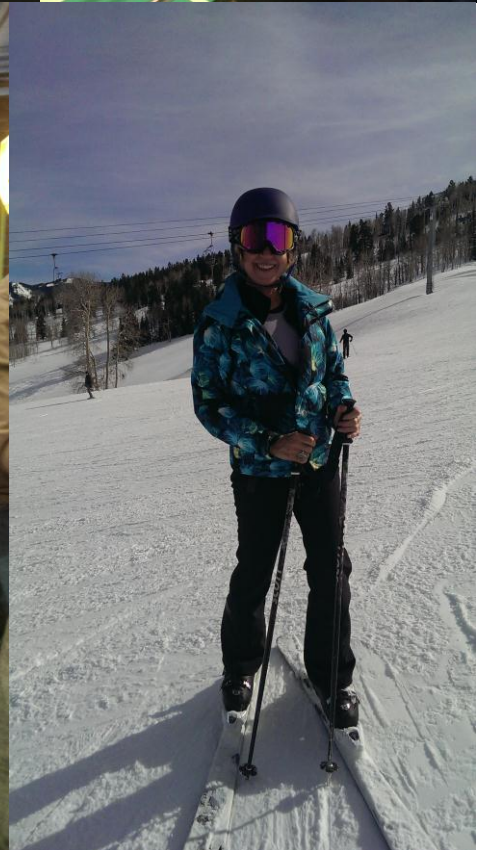

## **Red Mountain – The Last Great and Unspoiled Resort**
